

# 54th Annual LABOR DAY WEEKEND ARTS & CRAFTS FESTIVAL ~ Arnold, CA

## September 5th & 6th Hours: Sat: 10-5; Sun: 10-4

Mac Doogles Old Time Kettlecorn will be sponsoring the 54th Annual 'Labor Day Weekend Arts & Crafts Festival' over Labor Day weekend, Saturday and Sunday. The Market is held in the center of downtown Arnold, a mountain resort town on the road to Bear Valley Ski Resort on Highway 4, among the pines and redwoods, on the grounds of Bristol's Ranch House Café'.

The Festival is open to all craftspeople, artists, antique dealers, and all types of food booths. All food vendors – pre-packaged as well as prepared foods must get a Calaveras County Health Dptm. permit. All applications are juried by 4 - 5 photos of your product, plus a display photo. If you've participated in the show previously, we only need a display photo. All exhibitors must provide their own displays, awnings, etc. It is advantageous to apply early; we have a maximum of 65 booths and some categories fill quickly. Any work not juried previously will get you removed from the fair with no refund.

Set up is from Friday after 4pm (strongly suggested) or Sat after 6am. Our publicity is extensive in all three adjacent Mother Lode counties, and we hang a huge banner across Highway 4 in Arnold that is impossible to miss. RV, trailer, and over-sized vehicle parking is available across the street from the Market from 5pm Friday to 8pm Sunday. No hookups are available.

Entry fees are the same as last year: \$250 for arts/crafts booths; \$250 for food booths, including pre-packaged foods. If paying with a credit or debit card, a \$10 fee will be added.

Fill out the application below, cut off, and send it along with 4 - 5 photos of your product, a display photo, & your application fee. Past vendors – display photo only. Send a self-addressed, stamped envelope (with postage) if you want your photos/materials returned. You can email photos if you prefer, but you must mail in your application and fee. If you email photos, PLEASE REFER TO THE DATE YOU EMAILED THEM ON YOUR APPLICATION SO THAT WE MAY REFER BACK TO THEM! All notices of acceptance or rejection will be emailed to you.
